

# Ship Recycling Facility - Qualification Criteria





## **Regulations & International Conventions**

Ensure adherence to the Hong Kong International Convention for the Safe and Environmentally Sound Recycling of Ships, European Ship Recycling Regulation - No 1257/2013



## Handling of large FPSOs, NORM & Mercury waste

Demonstrated experience in managing NORM & Hg, including:

- Identification, safe removal and wastewater treatment
- Temporary storage and in compliance with regulatory standard.



## **Prohibition of Beaching Practices**

- Strictly prohibit beaching methods.
- Mandate the use of dry-dock or the landing on slope with drainage systems to guarantee environmental protection and worker safety.



# Ship Recycling Plan (SRP)

SRP defining responsibilities and procedures for dismantling, with focus on regulatory compliance, environmental protection, worker's health & safety, and waste segregation.



## **Certifications and Audits**

Possess relevant certifications (e.g., ISO standards).
Undergo regular audits to ensure ongoing compliance with safety and environmental regulations.



### **Marine Growth**

Clear guidelines regarding Marine Growth Removal/Management, particularly invasive species such as sun coral (*Tubastraea spp.*), to prevent ecological contamination.



# Hazardous Materials Management

Ensure safe identification, handling, and removal of hazardous materials such as asbestos, PCBs, ozone-depleting substances, heavy metals, and residual oils, in full compliance with international regulations.
